## THE RENT CONTROL DEVICE IS TO BE APPLIED IN PARIS FROM AUGUST 1ST

### ACCORDING TO ALUR LAW

**USPA NEWS** - The new Paris of rent control device applies to residential leases signed in Paris on 1 August 2015, according to the decree signed by Jean-François Carenco Prefect of the Ile-de-France, prefect of Paris published June 26, 2015 and pursuant to ALUR law.

THE NEW DEVICE IS MONITORED BY THE ADIL 75 UNDER THE DRIHL'S AUTHORITY-----

This order is based on the observation of rent actually charged in the current leases by the approved methods of the Observatory of Rents of the Paris agglomeration (OLAP), which involved the city of Paris and the data emanating professionals real estate, institutional and private landlords and tenants.-----

“This order establishes each year a basic rent, plus a reference rent and a minus reference rent, expressed by a price per square meter of living space, according to housing types and geographical areas.

All information relating to the operation of this device are monitored by the DRILL
